OPINION

Application 11805 having been filed and a protest against approval thereof having been received, was regularly set for a field investigation of which applicant and protestant were duly notified and did agree, by signed stipulations, to abide by the report and subsequent findings of said investigation.

The report of the investigation indicates that, as a result of a conference held at the conclusion of the investigation, the protestant was agreeable to withdrawal of his protest if applicant would reduce the amount proposed to be stored under Application 11805 to 5 acre feet per annum.

Applicant did, on July 30, 1947, file written authorization to amend Application 11805 to provide for a reduction of the amount proposed to be stored to 5 acre feet per annum and the application was so amended and protestant did, on July 30, 1947, file a written request for withdrawal of his protest on the condition that the application be so amended and there would now appear to be no bar to approval of Application 11805 and since the uses to which applicant proposes to put the waters sought are beneficial ones it is the opinion of the State Engineer that said application should be approved subject to the usual terms and conditions.

ORDER

Application 11805 for a permit to appropriate water having been filed with the Division of Water Resources as above stated, protests having been filed, a field investigation having been made, a stipulated hearing having been held in accordance with Article 13, Section 733b of the Administrative Code and the State Engineer now being fully informed in the premises:

IT IS HEREBY ORDERED that Application 11805 be approved for 0.2 cubic foot per second from about March 1 to about November 15 of each season and throughout the remainder of the year as required for domestic purposes, and for 5 acre feet per annum by storage to be collected, at a maximum rate of diversion to storage of 0.2 cubic foot per second, from about October 1 to about April 1 of each season and that a permit be issued to applicant subject

to the usual terms and conditions as may be appropriate.
