DECISION APPROVING APPLICATION

Alice Day having filed Application 17414 for a permit to appropriate unappropriated water; protests having been received; the applicant and protestants having stipulated to proceedings in lieu of hearing as provided for by Title 23, California Administrative Code, Section 737; an investigation having been made by the State Water Rights Board pursuant to said stipulation; the Board, having considered all available information and now being fully advised in the premises, finds as follows:

1. Application 17414 is for a permit to appropriate 0.25 cubic foot per second from Miners Ravine in Placer County between April 15 and October 15 of each year for irrigation use within Section 7, T11N, R8E, MDB&M.

2. Applicant purchases water from a public utility, using the stream flow as a supplemental supply. Any runoff from the applicant's irrigation, including purchased water, flows back into the named source. The stream flow at the applicant's point of diversion is sufficient to supply the amount requested by the applicant for the season of use.

Accretions to the stream are substantial between the applicant's diversion and those of downstream diverters. Using reasonable methods of operation, there is usually water in sufficient quantity to meet the needs of the protestants.

3. Construction of the applicant's diversion works was completed in 1956.

4. There is unappropriated water available to supply the applicant, and subject to suitable conditions, such water may be diverted and used in the manner proposed without causing substantial injury to any lawful user of water.

5. The intended use is beneficial.

From the foregoing findings, the Board concludes that Application 17414 should be approved and that a permit should be issued to the applicant subject to the terms and conditions set forth in the following Order.

The records, documents, and other data relied upon in determining the matter are: Application 17414 and all relevant information on file therewith, particularly the report of the field investigation made November 15, 1957; records of the water-stage recorders installed by the State Water Rights Board; United States Geological Survey quadrangle maps "Pilot Hill" and "Rocklin" both of the 7½ minute series.

IT IS HEREBY ORDERED that Application 17414 be, and the same is, approved, and that a permit be issued to the applicant subject to vested rights and to the following terms and conditions:

1. The amount of water to be appropriated shall be

limited to the amount which can be beneficially used and shall not exceed 0.25 cubic foot per second to be diverted between about April 15 and about October 15 of each year. The equivalent of such continuous flow allowance for any thirty-day period may be diverted in a shorter time if there be no interference with vested rights.

2. Complete application of the water to the proposed use shall be made on or before December 1, 1961.

3. Progress reports shall be filed promptly by permittee on forms which will be provided annually by the State Water Rights Board until license is issued.

4. All rights and privileges under this permit, including method of diversion, method of use, and quantity of water diverted are subject to the continuing authority of the State Water Rights Board in accordance with law and in the interest of the public welfare to prevent waste, unreasonable use, unreasonable method of use, or unreasonable method of diversion of said water.
