# NOTICE OF IN-PERSON LISTENING SESSION ON WATER MEASUREMENT AND REPORTING REGULATION ADOPTED PURSUANT TO 2015 SENATE BILL 88

State Water Resources Control Board (State Water Board or Board) staff will hold an in-person listening session to receive public input on the water measurement and reporting regulation adopted pursuant to 2015 Senate Bill 88 (SB-88). During the listening session, there will be a short staff presentation on the background, purpose, and requirements of the measurement and reporting regulation followed by an opportunity for public input and questions.

#### **BACKGROUND AND PURPOSE**

California's recent droughts have highlighted the need for high-quality water diversion data. Codified in the California Code of Regulations, title 23, sections 931-938, SB-88 requires that diverters above a certain size measure and report their diversion volumes to the Board. While the regulation has been in effect for several years, compliance with the requirements remains low, and the quality of diversion data submitted pursuant to the regulation is highly variable.

Board staff are evaluating ways to increase compliance and data quality. Options include developing formal guidance to clarify regulatory requirements, developing templates, and updating or modifying the current regulations. State Water Board staff are soliciting public feedback and input on the SB-88 measurement and reporting requirements, and are offering an in-person comment and listening session for the public to share their feedback.
