Notice of Temporary Permit Applications T033397, T033398, and T033399

The California Department of Water filed three temporary permit applications with the State Water Resources Control Board (State Water Board), Division of Water Rights, pursuant to Water Code section 1425. The projects associated with the applications are located in Imperial County and would divert water from the Salton Sea stream system.

Summary of Temporary Permit Application T033397

Type of Temporary Permit: 180-day Temporary Permit

Date of Filing: The application was filed with the State Water Board on October 18, 2023.

Source of Water: The sources of water are Big Wash, Grave Wash, and Palm Wash, which are all tributary to the Salton Sea.

Amount: The maximum amount of water requested for diversion is 140.2 acre-feet, which would be diverted at a maximum combined rate for all points of diversion not to exceed 146 cubic feet per second.

Season of Diversion: The season for diversion of water would be from November 1, 2023 to April 28, 2024.

Points of Diversion: Water will be diverted from 9 points within Township 9 South, Range 10 East, San Bernardino Base and Meridian as shown in the table below:

Place of Use: The place of use for water is 317.2 acres within sections 30 and 32, Township 9 South, Range 10 East, San Bernardino Base and Meridian.

Summary of Temporary Permit Application T033398

Type of Temporary Permit: 180-day Temporary Permit

Date of Filing: The application was filed with the State Water Board on October 18, 2023.

Source of Water: The sources of water are three unnamed washes, which are all tributary to the Salton Sea.

Amount: The maximum amount of water requested for diversion is 4.4 acre-feet, which would be diverted at a maximum combined rate for all points of diversion not to exceed 2.24 cubic feet per second.

Season of Diversion: The season for diversion of water would be from November 1, 2023 to April 28, 2024.

Points of Diversion: Water will be diverted from 4 points within Township 9 South, Range 12 East, San Bernardino Base and Meridian as shown in the table below:

Purpose of Use: The purposes of use for water are irrigation and dust suppression.

Place of Use: The place of use for water is 92.6 acres within sections 29, 32, and 33, Township 9 South, Range 12 East, San Bernardino Base and Meridian.

Summary of Temporary Permit Application T033399

Type of Temporary Permit: 180-day Temporary Permit

Date of Filing: The application was filed with the State Water Board on October 18, 2023.

Source of Water: The sources of water are Tule Wash and an unnamed wash, which are tributary to the Salton Sea.

Amount: The maximum amount of water requested for diversion is 168 acre-feet, which would be diverted at a maximum combined rate for all points of diversion not to exceed 84.9 cubic feet per second.

Season of Diversion: The season for diversion of water would be from November 1, 2023 to April 28, 2024.

Points of Diversion: Water will be diverted from 11 points within Township 10 South, Ranges 10 and 11 East, San Bernardino Base and Meridian as shown in the table below:

Procedure for Filing Objections

Pursuant to Water Code section 1428, any interested person may file an objection against the approval of the subject applications. Objections should be submitted via email to the staff contact listed below but may also be submitted via regular mail or

hand delivered. If objections are sent by mail or hand delivered, please provide a courtesy email to the staff contact listed below.

Objections must be received by the Division of Water Rights or postmarked by **4:30 p.m.** on **November 27, 2023**, with copy provided to the applicant. The State Water Board may, for good cause shown, allow additional time to file an objection.

Pursuant to Water Code section 1428, the board may issue a temporary permit in advance of public notice. Consequently, temporary permits may be issued on the applications before the end of the noticing period.
