## State Water Resources Control Board

### Notice of Water Right Applications A032016 and A032017

Seavey Ranch, LLC has filed two applications to appropriate water by permit with the State Water Resources Control Board (State Water Board), Division of Water Rights. The project associated with the applications is located in Napa County and would divert water from the Conn Creek stream system.

#### Summary of Water Right Application A032016

**Date of Filing:** The application was filed with the State Water Board on March 29, 2013.

**Sources of Water:** The sources of water are (1) Unnamed Stream tributary to Conn Creek and (2) Conn Creek thence Napa River thence San Pablo Bay.

**Amount:** The maximum amount of water requested for diversion is 29 acre-feet per year by direct diversion at a maximum rate of 2.9 cubic feet per second.

**Season of Diversion:** The season for diversion of water is from March 1 through May 14 of each year.

#### Points of Diversion (POD):

Water will be diverted from two points:

- Point 1 (POD and point of redirection) is an onstream reservoir located at North 1,947,410 feet and East 6,447,863 feet by California Coordinate System, Zone 2, North American Datum 1983, within the southeast quarter of the southeast quarter of Section 27, Township 8 North, Range 5 West, Mount Diablo Base and Meridian.
- Point 2 (POD) is a pipe located at North 1,946,496 feet and East 6,447,662 feet by California Coordinate System, Zone 2, North American Datum 1983, within the northwest quarter of the northeast quarter of Section 34, Township 8 North, Range 5 West, Mount Diablo Base and Meridian.

**Purpose of Use:** The purpose of use for water is frost protection.

**Place of Use:** The place of use for water consists of 55 acres for frost protection located within Sections 27, 34, and 35 of Township 8 North, Range 5 West, Mount Diablo Base and Meridian.

## Summary of Water Right Application A032017

**Date of Filing:** The application was filed with the State Water Board on March 29, 2013.

**Sources of Water:** The sources of water are (1) an Unnamed Stream tributary to Conn Creek and (2) Conn Creek thence Napa River thence San Pablo Bay.

**Amount:** The maximum amount of water requested for diversion is 27.6 acre -feet per year. This includes 24.6 acre-feet per year of diversion to storage and 3 acre-feet per year of direct diversion at a rate of 2.9 cubic feet per second.

**Season of Diversion:** The season for direct diversion of water is from April 15 through May 14 of each year. The season for diversion of water to storage is from November 1 through May 14 of each year.

### Points of Diversion (POD) and Places of Storage:

Water will be diverted from two points:

- Point 1 (POD, point of rediversion, and place of storage) is an onstream reservoir located at North 1,947,410 feet and East 6,447,863 feet by California Coordinate System, Zone 2, North American Datum 1983, within the southeast quarter of the southeast quarter of Section 27, Township 8 North, Range 5 West, Mount Diablo Base and Meridian.
- Point 2 (POD) is a pipe located at North 1,946,496 feet and East 6,447,662 feet by California Coordinate System, Zone 2, North American Datum 1983, within the northwest quarter of the northeast quarter of Section 34, Township 8 North, Range 5 West, Mount Diablo Base and Meridian.

**Purpose of Use:** The purposes of use for water are irrigation, frost protection, heat control, and stockwatering.

**Place of Use:** The place of use for water consists of 55 acres located within Sections 27, 34, and 35 of Township 8 North, Range 5 West, Mount Diablo Base and Meridian.

Protests must be received by the Division of Water Rights or postmarked by **January 20, 2025**, with copy provided to the applicant.
