## State Water Resources Control Board

### Notice of Water Right Applications A032122 and A033066

The California Department of Forestry and Fire Protection has filed two applications to appropriate water by permit with the State Water Resources Control Board (State Water Board), Division of Water Rights. The project associated with the applications is in Mendocino County and would divert water from the Noyo River, Big River, Caspar Creek, and Hare Creek stream systems.

#### Summary of Water Right Application A032122

**Date of Filing:** The application was filed with the State Water Board on June 13, 2013.

**Source of Water:** The sources of water are North Fork Caspar Creek and South Fork Caspar Creek, which are tributary to Caspar Creek thence the Pacific Ocean.

**Amount:** The maximum amount of water requested for diversion is 1.987 acre-feet per year to be diverted at a maximum rate of 5,480 gallons per day.

**Season of Diversion:** The season for diversion of water is from April 1 to November 15 of each year.

**Points of Diversion:** Water will be diverted from two points:

The first point is located at North 2,262,380 feet and East 6,070,955 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Northeast quarter of the Southeast quarter of Section 3, Township 17 North, Range 17 West, Mount Diablo Base and Meridian.

The second point is located at North 2,254,882 feet and East 6,065,848 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Northeast quarter of the Northeast quarter of Section 16, Township 17 North, Range 17 West, Mount Diablo Base and Meridian.

**Purpose of Use:** The purpose of use for water is dust control and fire protection.

**Place of Use:** The place of use for water is 48,652 acres within the Jackson State Demonstration Forest shown on map dated October 14, 2019 on file with the State Water Board.

## Summary of Water Right Application A033066

**Date of Filing:** The application was filed with the State Water Board on August 12, 2019.

**Source of Water:** The sources of water are the North Fork Big River stream system, the South and North Forks of the Noyo River stream systems, the Caspar Creek stream system, and the Hare Creek stream system.

**Amount:** The maximum amount of water requested for diversion is 21.48 acre-feet per year to be diverted at a maximum rate of 35,000 gallons per day.

**Season of Diversion:** The season for diversion of water is from April 1 to November 15 of each year.

**Points of Diversion:** Water will be diverted from sixteen points:

The first point is located at North 2,255,662 feet and East 6,134,632 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Southwest quarter of the Northwest quarter of Section 11, Township 17 North, Range 15 West, Mount Diablo Base and Meridian.

The second point is located at North 2,257,578 feet and East 6,123,239 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Northeast quarter of the Northeast quarter of Section 8, Township 17 North, Range 15 West, Mount Diablo Base and Meridian.

The third point is located at North 2,277,487 feet and East 6,086,658 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Northeast quarter of the Southeast quarter of Section 19, Township 18 North, Range 16 West, Mount Diablo Base and Meridian.

The eleventh point is located at North 2,271,959 feet and East 6,121,480 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Southwest quarter of the Northeast quarter of Section 29, Township 18 North, Range 15 West, Mount Diablo Base and Meridian.

The twelfth point is located at North 2,276,870 feet and East 6,116,357 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Southwest quarter of the Northeast quarter of Section 19, Township 18 North, Range 15 West, Mount Diablo Base and Meridian.

The thirteenth point is located at North 2,264,860 feet and East 6,081,834 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Northwest quarter of the Northwest quarter of Section 6, Township 17 North, Range 16 West, Mount Diablo Base and Meridian.

The fourteenth point is located at North 2,272,735 feet and East 6,085,150 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Northwest quarter of the Southeast quarter of Section 30, Township 18 North, Range 16 West, Mount Diablo Base and Meridian.

The fifteenth point is located at North 2,259,208 feet and East 6,061,009 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Southwest quarter of the Northwest quarter of Section 9, Township 17 North, Range 17 West, Mount Diablo Base and Meridian.

The sixteenth point is located at North 2,258,038 feet and East 6,064,605 feet by California Coordinate System, Zone 2, North American Datum 1983, within the Northwest quarter of the Southeast quarter of Section 9, Township 17 North, Range 17 West, Mount Diablo Base and Meridian.

**Purpose of Use:** The purpose of use for water is dust control and fire protection.

**Place of Use:** The place of use for water is 48,652 acres within the Jackson State Demonstration Forest shown on map dated October 14, 2019 on file with the State Water Board.

Protests must be received by the Division of Water Rights by **4:30 p.m. on March 21, 2023**, with copy provided to the applicant.
