On behalf of Petitioner City of Sacramento ("City") and Co-Petitioner Sacramento Suburban Water District ("SSWD"), enclosed are the following:

The City and SSWD are petitioning to add points redirection, places of use and purposes of use to Permit No. 11360 for the purpose of transferring a total of 6,000 acre-feet of water through groundwater substitution to the Department of Water Resources' 2009 Drought Water Bank. As you are aware, the Governor proclaimed a drought emergency on February 27, 2009 and requested in paragraph 3 of his proclamation that the State Water Board and DWR expedite the processing of water transfers and related drought mitigation measures. Your staff's prompt attention to and cooperation in processing the attached petition would be appreciated.


