Subject: Amended Petition for Temporary Change – CVP Permits 273 et al, Central Valley Project (including Friant Division), California

Dear Ms. Evoy:

Please find enclosed 21 amended Petitions for Temporary Change (Petitions) for 19 Central Valley Project (CVP) permits and one CVP license filed pursuant to Water Code Section 1700. The Bureau of Reclamation (Reclamation) originally filed these Petitions in November 2011 to temporarily modify the municipal and industrial place of use for three Friant Division permits and one license (permits 11885, 11886, 11887; license 1986), and the Consolidated Place of Use (CPOU) approved in Water Rights Decision 1641 for the 18 CVP permits associated with the CPOU, in order to facilitate water exchanges between Arvin-Edison Water Storage District (a CVP contractor) and Metropolitan Water District of Southern California (a SWP contractor).

In November 2011, your staff informed us that we had filed these petitions using the wrong form. Attached are the corrected temporary transfer petition forms and environmental information documents for each of the permits and one license.
