Subject: Extension Request for Proposed Amendments to the 2006 Water Quality Control Plan for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary

## Dear Ms. Marcus:

The Bureau of Reclamation and the U.S. Fish and Wildlife Service (Service) have preliminarily reviewed the recirculated Draft Substitute Environmental Document (SED) and the draft Scientific Basis Report issued by the State Water Resources Control Board (SWRCB) on September 15, 2016, and October 19, 2016, respectively, as part of a four-phase process of developing and implementing updates to the *Water Quality Control Plan for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary* (Bay-Delta Plan). The SWRCB has indicated it will accept written comments on the recirculated Draft SED (Phase 1) until the deadline of "no later than 12:00 noon on January 17, 2017." The SWRCB has also set a deadline for written comments on the draft Scientific Basis Report (Phase 2) until "no later than 12:00 noon on December 16, 2016."

The Bay-Delta Plan was last updated in 2006 and identifies beneficial uses of water in the Bay-Delta estuary, water quality objectives to protect those uses, and a program of implementation to achieve the water quality objectives. In Phase I, the SWRCB is proposing to update the Bay-Delta Plan's San Joaquin River flow and southern Delta salinity water quality objectives and the program of implementation for those objectives. Phase II identifies and proposes the science that the SWRCB will be relying on when determining the potential changes to the Bay-Delta Plan with regards to increasing flows within the Sacramento River basin and the Bay-Delta to protect beneficial uses.

Given the length of time since the 2006 Bay-Delta Plan's last update, the ramifications of proposed changes, the complexity of the documents and appendices, and the restriction of having only a single opportunity to comment prior to changes being implemented, Reclamation and the Service respectfully request that both the comment periods on these documents be extended. We request that the comment period on the recirculated Draft SED be extended for approximately 120 days to May 15, 2017, and the comment period on the draft Scientific Basis Report to be extended for approximately 60 days to February 15, 2017. These extensions would allow the Department of the Interior to sufficiently evaluate the scientific justification and feasibility of the SWRCB's proposed updates to the 2006 Bay-Delta Plan.

Granting the requested extensions will afford the Department of the Interior the opportunity to coordinate our comments with others to the extent possible, as well as provide the most thoughtful and meaningful information to the SWRCB. These extensions would be similar to those issued by the SWRCB for the California WaterFix, which has equally complex actions.
