#### PURPOSE OF THE WORKSHOP

The purpose of this workshop is for the State Water Resources Control Board (State Water Board) to receive comments and other technical information related to its draft Technical Report on the scientific basis for alternative San Joaquin River flow and southern Delta salinity objectives (Draft Technical Report). The information and tools described in the draft Technical Report are intended to provide the State Water Board with the scientific information and tools needed to consider potential changes to the San Joaquin River flow and southern Delta salinity objectives included in the 2006 Water Quality Control Plan for the San Francisco Bay/Sacramento-San Joaquin Delta Estuary (2006 Bay-Delta Plan), and a program of implementation to achieve these objectives. This workshop is being held to determine whether: 1) this information and these tools are sufficient to inform the State Water Board's decision-making to establish San Joaquin River flow and southern Delta salinity objectives and a program of implementation to achieve these objectives; and 2) the State Water Board should consider additional information or tools to evaluate and establish San Joaquin River flow and southern Delta salinity objectives, and a program of implementation to achieve these objectives. Through this process, the State Water Board will develop the tools it will then use to prepare the Substitute Environmental Document (SED) and any revisions to the objectives.

The State Water Board will provide for an independent peer review of the scientific basis and modeling contained in the Technical Report following the workshop. Comments received during the workshop will inform what, if any, changes should be made to the Technical Report prior to the scientific peer review. Comments received as part of this workshop along with the scientific peer review comments will also inform the State Water Board's review of the southern Delta salinity and San Joaquin River flow objectives in the Bay-Delta Plan.

## **FORMAT OF THE WORKSHOP**

The workshop will begin with a staff presentation of the Draft Technical Report followed by panel discussions by State Water Board staff and technical experts on the following topics discussed in the draft Technical Report: 1) hydrologic analysis of the San Joaquin River Basin; 2) scientific basis for developing alternate San Joaquin River flow objectives; 3) scientific basis for developing alternative southern Delta salinity objectives; and 4) water supply impacts of potential alternative San Joaquin River flow and southern Delta salinity objectives. The panelists and State Water Board staff will be given the opportunity to discuss and answer a series of topic-specific questions related to the draft Technical Report and, if time allows, on the comments and other material submitted by participants. State Water Board members or staff may direct questions to individual participants or entire panels. The public may submit questions related to the four topics for the State Water Board to consider asking the panelists. Instructions for submitting comments and participating in the workshop are provided below. The deadline for submitting comments and requesting to participate on the panels is Monday, December 6, 2010, and the deadline for submitting proposed questions for discussion during the workshop is Wednesday, December 22, 2010.

## **BACKGROUND**

In July of 2008, the State Water Board adopted a Strategic Workplan for Activities in the Bay-Delta, which identifies actions that the State Water Board, Central Valley Regional Water Quality Control Board, and San Francisco Bay Regional Water Quality Control Board will take to protect beneficial uses in the Bay-Delta. Among other activities, the Strategic Workplan calls for the review and potential amendment of the southern Delta salinity and San Joaquin River flow objectives included in the 2006 Bay-Delta Plan and their implementation.

On February 13, 2009, the State Water Board released a *Notice of Preparation and of Scoping Meeting for Environmental Documentation for the Update and Implementation of the Bay Delta Plan: Southern Delta Salinity and San Joaquin River Flows*, and the associated scoping meeting was held on March 30, 2009. Also on February 13, 2009, the State Water Board issued a notice of public staff workshop, which was subsequently held on April 22, 2009, to receive further information and conduct discussions regarding southern Delta salinity and San Joaquin River flow objectives. A follow-up staff workshop was held on June 19, 2009, to update the public on progress to date with associated San Joaquin River flow modeling. On August 13, 2009, and November 11, 2009, two public staff workshops were held as a continuation of that process as it related to southern Delta salinity, specifically for Dr. Glen Hoffman to present the draft study report entitled *Salt Tolerance of Crops in the Southern Sacramento-San Joaquin Delta* (Study Report) and discuss responses to written comments and how the comments would be addressed in the final Study Report.

The State Water Board will have limited time to ask questions so proposed questions should be directly related to the topics in the draft Technical Report and should be prioritized by importance (the State Water Board suggests that each participant limit questions to no more than ten questions per panel). 

**PARKING, ACCESSIBILITY, AND SECURITY**




