Dear Co-Hearing Officers,

Clifton Court, L.P. (CCLP) hereby joins in Deirdre Des Jardins' February 13, 2018 Motion to Formally Consider Additional Information Submitted in Support of Petition. The WaterFix change petition does not provide the information required on changes to flows and water levels near Clifton Court Forebay. We've already had problems with our levies and they could get worse if Clifton Court Forebay is enlarged and deepened. We are just individual water right holders and the download link I received for CWF H3+ modeling data does not link to anything I can read, nor have I received a user friendly hard copy by U.S. Postal service. I request that the Hearing Officers require DWR to send me a readable table of expected changes to flows and water levels near Clifton Court Forebay, before Part 2 of the hearing commences.

Also, Section 794, subdivision (a)(7) of the Board's regulations requires that the WaterFix water right change petition include information on "any changes in property ownership(s) involved." I had to find out in private meetings with DWR during Part 1 that they were proposing to condemn our property. It's not clear that DWR will even end up owning our property, since Metropolitan Water District is now proposing to take over the project construction. The Hearing Officers should require DWR and MWD to provide full information on the property acquisition plans for the WaterFix, including what properties in the Delta are proposed to be acquired, and by what entity.

Clifton Court L.P. also strongly supports the request in Deirdre Des Jardin's motion that the Petitioners be required to provide a response to the protests we filed. We were sandbagged in Part 1 when the Department of Water Resources submitted 50 year old court documents during sur-rebuttal for Official Notice, which we then had no opportunity to rebut. If DWR had provided a written response to Clifton Court L.P.'s protest in advance of the hearing, as the Board's regulations require, then we would have known to hire an attorney to testify on the interpretation of the court documents. It is fundamentally unfair to require detailed written protests but not require detailed written responses.

These may seem like small details for such a huge project but having the information in time to use it in Part 2 is essential to our family receiving due process in this hearing.


