Dear California WaterFix Hearing Officers, Staff and All Parties:

Attached please find the revised CCC-SC exhibit identification list and CCC-SC 56 errata exhibit. Also attached is our statement of service.

Additionally, during his rebuttal testimony on August 17, 2018, Dr. Richard Denton noted on the record that there is an error at page 14, line 8 of his written rebuttal testimony (CCC-SC-51). Dr. Denton explained that the word “not” was inadvertently omitted from that line of text, and the line of text should read: “6.3 below, there are significant adverse water quality impacts in CWF H3+ that were not in”. The hearing officers confirmed the correction on the record and also advised that an errata exhibit was not required.
