Vickie Newlin provided an update on the Technical Advisory Committee (TAC). There was no TAC meeting in September because of the Board Meeting. At the October TAC meeting, State officials provided updates on SGMA and Proposition 1 funding for SGMA and groundwater projects. Bill Ehorn gave an update on current groundwater conditions featuring groundwater elevation maps. During the November TAC meeting individuals gave updates on the Mid and Upper Sacramento River and the Feather River Regional Flood Management planning process and related projects. Ryan Teubert gave an update on the current El Nino weather patterns with predictions for Northern California. County representative met after the TAC meeting to discuss SGMA.
