CalEPA

- Mission- restore, protect and enhance the environment, to ensure public health, environmental quality and economic vitality
- Consists of the following offices, boards, and departments:
 - State Water Resources Control Board
 - Air Resources Board
 - Department of Resources Recycling and Recovery
 - Department of Pesticide Regulation
 - Department of Toxic Substances Control
 - Office of Environmental Health and Hazard Assessment







- Mission- preserve, enhance, and restore the quality of California's water resources and drinking water for the protection of the environment, public health, and all beneficial uses, and to ensure proper water resource allocation and efficient use, for the benefit of present and future generations
- Responsible for allocating surface water rights and protecting water quality, while protecting the public trust and public interest and preventing the waste and unreasonable use of water
- Responsibilities converge in the Bay-Delta

Bay-Delta Plan

- Identifies beneficial uses of water, water quality objectives to protect those uses, a program of implementation to achieve the objectives, and monitoring and special studies
 - Beneficial uses: municipal and industrial, agricultural, fish and wildlife
 - Water quality objectives: narrative and numeric (primarily flow-dependent)
 - Program of Implementation: flow and nonflow actions
- Require periodic/triennial review






Sac/Delta Update to the Bay-Delta Plan Possible Sac/Delta Plan Amendments

- 2018 Sac/Delta Framework
 - Sacramento River & Delta Eastside (Cosumnes, Mokelumne, and Calaveras) tributary inflows and cold-water habitat: 55% of unimpaired flows with adaptive range from 45-65%
 - Sacramento River & Delta Eastside tributary cold-water habitat
 - Delta outflows inflow-based outflows
 - Interior Delta flows- State Water Project and Central Valley Project operational constraints
- 2022 VA MOU
 - 8-year term with possible extension, modification, or regulatory paths following
 - Sacramento River and Delta tributary inflows (Tuolumne River VA would be considered separately)
 - Delta outflows
 - Habitat restoration

VA Background: Key Provisions

- A new narrative objective to achieve the viability of native fish populations and proposal to contribute to existing Salmon Protection (salmon doubling) objective
- Flow and habitat assets, with science and governance
- Dual compliance pathways
 - VA path
 - Regulatory path
- Annual and triennial reports to State Water Board
- "Green, yellow, and red light" decision structure at year 8
