NOTICE OF PUBLIC WORKSHOP

Consideration of the Pelagic Organism Decline in the San Francisco Bay/Sacramento-San Joaquin Delta Estuary

SUBJECT OF WORKSHOP

The purpose of this workshop is to receive information regarding the Pelagic Organism Decline (POD) in the San Francisco Bay/Sacramento-San Joaquin Delta Estuary (Bay-Delta). At the workshop, the State Water Resources Control Board (State Water Board) will collect information that may be used in a proceeding to update the current Water Quality Control Plan for the Bay-Delta (Bay-Delta Plan) or to support other actions that the State Water Board may consider to improve fishery resources of the Bay-Delta.


BACKGROUND

The Bay-Delta includes the Sacramento-San Joaquin Delta, Suisun Marsh, and the embayments upstream of the Golden Gate. The Delta and Suisun Marsh are located where California's two major river systems, the Sacramento and the San Joaquin Rivers, converge to flow westward to meet the incoming seawater tides flowing through the San Francisco Bay. The watershed of the Bay-Delta is a critical source of water supply for much of California. The watershed is a source of drinking water for two-thirds of the State's population. It supplies some of the State's most productive agricultural areas, and it provides water for fish, wildlife, and other public trust uses within and upstream of the Bay-Delta Estuary.

In recent years there has been a marked decline in numerous pelagic fishes in the Delta and in Suisun Bay. The on-going decline of delta smelt, a federal and State threatened species, is of particular concern.

On December 4, 2007, the State Water Board adopted Resolution No. 2007-0079, which describes water quality and water right activities the State Water Board, Central Valley Regional Water Quality Control Board, and San Francisco Bay Regional Water Quality Control Board will

undertake in the Bay-Delta to address the POD and other significant Bay-Delta issues. The State Water Board committed in this resolution to prepare a strategic workplan by June 2008 that prioritizes and describes the scope of these activities and provides specificity regarding timelines and resource needs for implementing coordinated activities in the Bay-Delta, including those related to addressing the POD. The State Water Board is seeking information through this workshop to inform these water quality and water right activities.

MATTERS FOR DISCUSSION IN THE WORKSHOP

The State Water Board is seeking to obtain information and specific recommendations for actions to improve fishery resources that have been developed since the State Water Board's June 19, 2007 workshop on POD issues. At the current workshop, the State Water Board requests that participants address the following matters:

- 1) The status of the National Center for Ecological Analysis and Synthesis (NCEAS) report summarizing the latest POD work team efforts;
- 2) The findings of toxicological studies related to the POD, including ammonia discharge and its effect on the lower trophic level of the Delta food chain;
- 3) The significance of scientific information derived from critically low population levels of pelagic species;
- 4) Any new findings related to effects of water exports, invasive species, and contaminants;
- 5) A status update on the development of a delta smelt refuge; and
- 6) Short-term and long-term actions the State Water Board should consider under its various authorities to improve habitat conditions for fishery resources.

PROCEDURAL MATTERS

Participants are required to provide their written materials, including scopes of work and study plans, by 12 p.m. on January 8, 2008. At the workshop, participants will be given an opportunity to summarize and supplement their written materials with oral presentations. In order to ensure a productive and efficient workshop in which participants have an opportunity to participate, time limits may be imposed on oral presentations. Participants with similar comments are requested to make joint presentations.

The workshop will be informal. There will be no sworn testimony or cross-examination of participants, but the State Water Board and its staff may ask clarifying questions.



PARKING AND ACCESSIBILITY


