# NOTICE OF PUBLICLY AVAILABLE CHANGES TO THE PROPOSED WATER MEASUREMENT AND REPORTING REVISIONS

Changes to California Code of Regulations, Title 23

**NOTICE IS HEREBY GIVEN** that the State Water Resources Control Board (State Water Board or Board) has further updated the text of the proposed revisions to California Code of Regulations, title 23, chapters 2 (Appropriation of Water), 2.7 (Water Diversion and Use Reports), and 2.8 (Measuring and Monitoring) based on comments from the public. The updated regulation text is available for written public comments that will be considered prior to the Board's consideration of the proposed regulation. The State Water Board is accepting comments on the proposed changes only, which constitute minor clarifications to the proposed regulation based on public comments to the proposed regulation.

The updated regulation text is labeled "Updated Proposed Text for Chapters 2 and 2.7 - Corrected Formatting" and "Updated Proposed Text for Chapter 2.8 v3." The proposed changes for chapter 2.8 are reflected with a single underline for additions and strikethrough for deletions when compared to the previous version released on May 22, 2025. The changes to chapter 2 and 2.7 only affected formatting, so there are no text changes reflected in underline or strikethrough.

### REVISIONS TO PROPOSED REGULATION TEXT

The proposed revisions in chapter 2.8 are necessary to:

- Correct an error in the previous version, clarifying that diverters of less than or equal to 10 acre-feet per year do not need to measure their diversions
- Fix typos
- Provide minor clarifications in response to comments

### WRITTEN COMMENT PERIOD AND SUBMITTAL OF COMMENTS

(Gov. Code, §§ 11346.5(a)(15), 11347.1)

Any interested person, or their representative, may submit written comments on the latest changes to the proposed regulatory text. Please note that at this time the State Water Board will only accept written comments on the latest revisions to the proposed regulatory text. The State Water Board will not be accepting additional comments on the revisions previously released. Any written comments on the revisions to the proposed regulatory text, regardless of the method of transmittal, must be received by the State Water Board by 5:00 p.m. PDT, on July 1, 2025, which is hereby designated as the close of the written comment period. Comments received after this date will not be considered timely.

Please note that under the California Public Records Act (Gov. Code, § 7920.000 et seq.), your written comments, attachments, and associated contact information (e.g., your address, phone, email, etc.) become part of the public record and can be released to the public in response to a request. Written comments to the State Water Board should avoid including personal identifiable information (e.g., social security number, etc.,) other than the minimum amount necessary to receive updates and notice of any additional proposed changes to the regulation text on which additional comments may be solicited.

After the close of the comment period, the State Water Board may adopt the proposed regulation. If additional substantive changes are made to the proposed regulation text, the modified full text will be made available for comment for at least 15 days prior to adoption.

After the final public comment period, the State Water Board will prepare a Final Statement of Reasons that updates the Initial Statement of Reasons, summarizes how the State Water Board addresses comments, and includes other materials.
