# ADMINISTRATIVE CIVIL LIABILITY ORDER

In the Matter of Failure to File Annual Water Diversion and Use Reports for the 2022 through 2023 Reporting Year

# 1.0 INTRODUCTION

The Assistant Deputy Director of the Division of Water Rights ("Division"), through authority delegated by the State Water Resources Control Board ("State Water Board"), issues this Administrative Civil Liability Order ("Order") to Robert C Pedotti ("Respondent"). On July 2, 2024, the Division issued the Respondent an Administrative Civil Liability Complaint ("Complaint"), which is incorporated by reference as part of this Order.

# 2.0 LEGAL AND PROCEDURAL BACKGROUND

1. Title 23, Chapter 2.7, Article 2, section 929 of the California Code of Regulations states that water right holders shall file reports with the State Water Resources Control Board annually, before February 1, detailing the amount of water diverted and used within the prior twelve-month reporting period ("Annual Water Diversion and Use Report").<sup>1</sup>

- 2. Title 23, Chapter 2.7, Article 2, section 908 of the California Code of Regulations states, "Failure to meet the requirements of this chapter is a violation subject to civil liability of up to \$500 per day pursuant to Water Code section 1846."
- 3. Water Right A013466 has a face value of 565.00 acre-feet per year as declared in the license issued on June 2, 1961. Water Right A018851 has a face value of 669.00 acre-feet per year as declared in the license issued on March 17, 1972.
- 4. The Respondent failed to file their Annual Water Diversion and Use Reports for the subject water rights before the required deadline of February 1, 2024.
- 5. On April 8, 2024, the Division sent a Notice of Violation ("NOV") via United States Postal Service informing the Respondent that the State Water Board had not received the required annual reports. The NOV informed the Respondent that that if they filed the delinquent Annual Water Diversion and Use Reports by May 8, 2024, then the Division would not issue an Administrative Civil Liability Complaint (ACLC).
- 6. The NOV informed the Respondent that failure to submit the Annual Water Diversion and Use Reports is a violation of the Water Diversion and Use Report Regulations for which the potential civil liability of five hundred dollars (\$500) may be assessed for each day that the report was not submitted after the deadline.
- 7. On July 2, 2024, the Division issued an ACLC. The ACLC alleged the Respondent failed to file the Annual Water Diversion and Use Reports for the 2022-2023 water year (October 1, 2022, through September 30, 2023). The ACLC recommended a penalty of \$6,000 and extended an opportunity to contest the penalty by requesting a hearing within 20 days of receiving the Complaint.
- 8. The ACLC was mailed to the Respondent via certified mail. The Division confirmed with the United States Postal Service that the ACLC was delivered to the Respondent's address of record on July 9, 2024.
- 9. The Respondent did not request a hearing within 20 days of receipt of the ACLC, in accordance with Water Code section 1055, subdivision (b).
- 10. Water Code section 1846 states that a person or entity may be liable for a violation of a regulation adopted by the State Water Board in an amount not to exceed five hundred dollars (\$500) for each day in which the violation occurs.
- 11. Pursuant to Water Code section 7, the State Water Board is authorized to delegate authority to the Deputy Director of Water Rights. Water Code section 1055, subdivision (b), Resolution No. 2012-0029, and subsequent redelegation memorandums authorize the Assistant Deputy Director of the Permitting and Enforcement Branch to issue an Order to the Respondent assessing administrative civil liability in the amount proposed in the Complaint.

- 12. Water Code section 1055.3 states that when determining the appropriate amount of civil liability to be imposed, the State Water Board shall take into consideration all relevant circumstances, including but not limited to the extent of the harm caused by the violation, the nature and persistence of the violation, the length of time over which the violation occurs, and the corrective actions, if any, taken by the violator.
- 13. In this case, the recommended administrative civil liability of \$6,000 is based on consideration of the relevant circumstances alleged in the ACLC. In consideration of these circumstances, the State Water Board has determined that the administrative civil liability of \$6,000 is appropriate.

### **ORDER**

# IT IS HEREBY ORDERED THAT:

- 1. The attached Complaint is incorporated herein and made part of this Order.
- 2. In adopting this Order, the State Water Board, or its delegee, has considered all relevant circumstances, including those specifically identified in the Complaint pursuant to Water Code section 1055.3.
- 3. The Respondent shall remit, within 30 days of the date of this Order, a check or money order payment of the full penalty of \$6,000 to:

- 4. Fulfillment of the Respondent's obligations under this Order constitutes full and final satisfaction of liability for the alleged violation specifically identified in this Order. The State Water Board reserves the right to take further enforcement action for any future violations.
- 5. The State Water Board is authorized to seek recovery of the liability imposed, as authorized by California Water Code section 1055.4, or refer this matter to the Office of Attorney General for further enforcement action if the fails to comply with remitting payment of the full penalty within 30 days of the date of this Order.
