ORDER APPROVING SETTLEMENT AGREEMENT

THE DEPUTY DIRECTOR1 FINDS AS FOLLOWS:

1.0 INTRODUCTION

This matter comes before the Deputy Director of the State Water Resources Control Board's ("State Water Board") Division of Water Rights ("Division") following settlement negotiations regarding the alleged violation of California Code of Regulations, Title 23, Chapter 2.7, Article 2, section 920 ("Water Diversion and Use Report Regulations"), as described in an Administrative Civil Liability Complaint ("Complaint") dated July 2, 2024. In accordance with the attached Acceptance of Settlement Offer and Waiver of Right to Hearing and Reconsideration ("Acceptance and Waiver"), the Division's Prosecution Team ("Prosecution Team") and Delbert Howard ("Respondent") have agreed to settle this matter in lieu of proceeding to a hearing. The Respondent has also waived their

right to request reconsideration of an order by the State Water Board resolving the violations alleged in the Complaint.

The Prosecution Team and the Respondent are collectively referred to as the Parties. The issuance of a decision or order pursuant to a settlement agreement is authorized under Government Code section 11415.60.

2.0 BACKGROUND

- 1. Water Code section 5101 states, in part, "Each person who...diverts water shall file with the board a statement of their diversion and use...For diversions after September 30, 2021, the statement...shall be filed before February 1."²
- 2. Water Code section 5104 states, in part, "Supplemental statements shall be filed annually...For diversions after September 30, 2021, the supplemental statement...shall be filed before February 1."
- 3. Title 23, Chapter 2.7 of the California Code of Regulations ("Water Diversion and Use Report Regulations") identifies requirements for mandatory filing of reports to the State Water Resources Control Board ("State Water Board"). Specifically, Article 2, section 920 of the Water Diversion and Use Report Regulations states that Supplemental Statements of Water Diversion and Use ("Supplemental Statement") shall be filed electronically with the State Water Board annually, detailing the amount of water diverted and used within the prior twelve-month reporting period.
- 4. Title 23, Chapter 2.7, Article 2, section 908 of the California Code of Regulations states, "Failure to meet the requirements of this chapter is a violation subject to civil liability of up to \$500 per day pursuant to Water Code section 1846."
- 5. Diversions reported under statement S000615 have a claimed amount of 543.00 acre-feet in the initial statement filed April 28, 1967. Diversions reported under statement S001845 have a claimed amount of 550.00 acre-feet in the most recent statement filed March 22, 2019. Diversions reported under statement S008911 have a claimed amount of 1.20 acre-feet in the initial statement filed August 11, 1976.
- 6. The Respondent failed to file their supplemental statements for the subject claims before the required deadline of February 1, 2024.

- 7. On July 2, 2024, the Division issued the Respondent an Administrative Civil Liability Complaint (ACLC). The ACLC alleged the Respondent failed to file supplemental statements for water diversion and use for the 2022-2023 water year (October 1, 2022 through September 30, 2023).
- 8. At the time of settlement, Respondent had not requested a hearing within 20 days of receipt of the ACLC, in accordance with Water Code section 1055, subdivision (b).

3.0 SETTLEMENT AGREEMENT

- 9. Concurrent with issuing the ACLC to the Respondent, the Division also extended a settlement offer for a reduced fine of \$2,400 provided the Respondent submitted the past due reports.
- 10. Respondent accepted and signed the Division's settlement offer on July 23, 2024.
- 11. Respondent has submitted the three past due statements.
- 12. Water Code section 1055.3 states that when determining the appropriate amount of civil liability to be imposed, the State Water Board shall take into consideration all relevant circumstances, including but not limited to the extent of the harm caused by the violation, the nature and persistence of the violation, the length of time over which the violation occurs, and the corrective actions, if any, taken by the violator.
- 13. In this case, the Respondent did engage in corrective action and ultimately submitted the outstanding statements on June 26, July 23, and July 29, 2024. The Prosecution Team and the Respondent agreed to settle the ACLC's allegations for an amount of \$2,400. In consideration of all relevant circumstances, the State Water Board, through the Deputy Director, has determined this an appropriate proposed penalty.

ORDER

IT IS HEREBY ORDERED THAT:

- 1. The attached Complaint and Acceptance and Waiver are fully incorporated herein and made part of this Order.
- 2. In adopting this Order, the State Water Board, or its delegee, has considered all relevant circumstances, including those specifically identified in the Complaint pursuant to Water Code section 1055.3.
- 3. Respondent shall remit, within 30 days of the date of this Order, a check or money order payment of the full settlement amount of \$2,400 to:

- 4. Fulfillment of the Respondent's obligations under this Order constitutes full and final satisfaction of liability for the alleged violation(s) specifically identified in this Order. The State Water Board reserves the right to take further enforcement action for any future violations.
- 5. Should Respondent fail to remit the full settlement amount of \$2,400 within 30 days of the date of this Order, the Respondent shall be considered in violation of the terms of this agreement. As such, the State Water Board is authorized by California Water Code section 1055.4 to recover the full liability amount proposed under the ACLC or refer this matter to the Office of the Attorney General for further enforcement action.
