## NOTICE OF VIOLATION: FAILURE TO COMPLY WITH ENHANCED REPORTING REQUIREMENT

To Whom It May Concern:

On August 20, 2021, you were issued an Initial Order Imposing Curtailment and Reporting Requirements which required water right holders and claimants with past or potential annual diversions of 5,000 acre-feet or more to submit data describing their prior diversions and projected demand, on a monthly timestep, to the Division of Water Rights (Division) for water allocation decisions. This monthly reporting requirement was implemented following approval of the emergency regulations (see Cal. Code Regs., title 23, section 879 (c)(2)).

As of the date of this letter, the Division has not received your July 2022 through September 2022 projected demand reports or your prior diversion reports from April 2022 through June 2022. The Division has also not received your projected demand report for November 2022 which was due on October 14, 2022.

Failure to submit the required reports inhibits the Division's ability to assess prior diversion and projected demand data for potential use in the Water Unavailability Methodology for the Delta Watershed, which is used to inform water right curtailments.

Failure to submit the required forms also constitutes a violation of State Water Board emergency regulations that may subject you to formal enforcement and potential monetary penalties (Water Code section 1846).

The Division is now preparing an Administrative Civil Liability Complaint (ACL Complaint) to issue you a potential fine for up to \$500 per day per water right for each day the reports were not filed. As of the date of this letter, the maximum potential fine is \$68,000 per right/claim (136 days from the June 7, 2022, due date for the April 2022 prior diversions report).

## The Division will NOT issue the ACL Complaint for this violation if:

 You submit your projected demand report for the November 2022 reporting period no later than Friday November 4<sup>th</sup>; the November 2022 projected report was due by October 14, 2022.

2. You timely submit your prior diversions and projected demand reports moving forward, beginning with the October 2022 prior report and the December 2022 projected report.
