NOTICE OF VIOLATION - UNAUTHORIZED DIVERSION AND USE OF WATER FROM AN UNNAMED STREAM TRIBUTARY TO LITTLE COW CREEK, SHASTA COUNTY APN

This matter requires your immediate attention.

The State Water Resources Control Board (State Water Board) Division of Water Rights (Division) notified you by letter dated October 7, 2021, that the reservoir on your property has no basis of right to divert water to storage. The Division also sent an additional letter on May 18, 2022. On June 22, 2023, you mentioned in a phone conversation with Division staff (Oxcar Macias), that you did not receive the letter. Enclosed is a copy of the May 18, 2022, letter.

In your phone conversation with Division staff on June 22, 2033, you explained that the reservoir's operation has been corrected so that all the outflow from your reservoir flows back into the original stream channel. You also mentioned that the reservoir is only for non-consumptive use such as aesthetics and fish and wildlife enhancement, and the reservoir is usually kept full when the stream channel is flowing. Because the water in the stream is caused by excess irrigated decreed diversions, your reservoir operation does not qualify for riparian rights. Therefore, an appropriative water right is required for your reservoir.

Within 30 days of receipt of this letter, you need to file an appropriative water right to divert water to storage.
