NOTICE OF VIOLATION - FAILURE TO COMPLY WITH CURTAILMENT ORDERS (WR ID(s): S024360 and SG003902)

The State Water Board adopted an emergency regulation establishing emergency minimum flows in the Scott River and Shasta River watersheds on December 19, 2023. (Cal. Code Regs., tit. 23, §§ 875-875.9.) The regulation went into effect on February 1, 2024, and will remain in effect for one year.

On July 23, 2024, the Deputy Director for the State Water Board Division of Water Rights (Division) issued the Order Imposing Water Right Curtailment and Requiring Reporting for Water Rights in the Scott River Watershed. United States Postal Service (USPS) records indicate that you received the Order for surface water rights on July 25, 2024, and the Order for adjudicated groundwater rights on July 29, 2024.

On August 1, 2024, Division staff observed and took photo documentation from public roads of irrigation occurring at your place of use, identified as Siskiyou County Assessor Parcel Numbers **County and County and County**

The Division may issue an Administrative Civil Liability Complaint (ACL Complaint), Cease and Desist Orders, or both at its discretion with a potential fine of up to \$500 per day per water right for each day a violation occurs.
