NOTICE OF VIOLATION

DIVISION OF WATER RIGHTS INVESTIGATION OF TRINITY COUNTY ASSESSOR PARCEL NUMBER (APN) 019-290-018-000

Cher Shoua Vang,

On August 6, 2025, staff from the State Water Resources Control Board (State Water Board), Division of Water Rights (Division), in coordination with California Department of Fish and Wildlife (CDFW) conducted a search warrant investigation of the property referenced above (Property). The purpose of the investigation was to observe the diversion and use of water occurring on the Property and to evaluate potential impacts to the watershed.

You are being contacted because you were identified as the property owner of the Trinity County APN identified above where you are allegedly diverting and using water for cannabis cultivation.

During the investigation, Division staff observed California Water Code (WC) and State Water Board, Cannabis Cultivation Policy (Policy) violations. Enclosed is the Division's Inspection Report (Report) that includes Division staff observations, alleged violations and the corrective actions necessary for compliance with the WC and the State Water Board's Policy. The enclosed Report constitutes your notice of the alleged violations and this matter requires your immediate attention.

The State Water Board retains the authority and discretion to take enforcement action based on the facts and allegations contained herein and you may be subject to further enforcement action before the State Water Board. Therefore, this matter requires your immediate attention. You should follow all staff recommended corrective actions described in the enclosed Report or submit a response indicating any course of action

you intend to take or have taken, include an implementation schedule, and/or photo documentation that demonstrates your compliance.
