### NOTICE OF VIOLATION - LOCAL COOPERATIVE SOLUTIONS (LCS) PROGRAM REPORTING DEFICIENCY

LCS applicants are subject to the reporting requirements proposed and established in their LCS Plan. Water Board staff have not received your LCS water use data for the month(s) of April. **Please attach your missing datafiles, including August 2026 data, in an email to [DWR-Siskiyounforcement@Waterboards.ca.gov](mailto:DWR-Siskiyounforcement@Waterboards.ca.gov) by September 10, 2026, or provide a justification explaining why the reporting was deficient for that month.** Data submissions must include water usage for all fields proposed in the LCS plan which may include both metered and unmetered fields.

On June 10, 2026, the State Water Board issued Order WR 2026-0008-DWR (Curtailment Order). The Curtailment Order imposed water right curtailment and required reporting for groundwater pumping under Schedule C of the Scott River Adjudication and overlying groundwater diversions (Priority Group 9) in the Scott River Watershed. The Curtailment Order also established that compliance with the groundwater local cooperative solution proposals is required upon submission, and throughout the review process. Non-compliance with reporting requirements may subject you to curtailment. Failure to comply with your LCS submission is a violation of the Curtailment Order and is subject to penalties of up to \$10,000 per day under Water Code Section 1846, subdivision (b).
