REPORT OF INSPECTION AND NOTICE OF VIOLATION FOR WATER RIGHTS LICENSE 5767 (A014045) AND LICENSE 13102 (A25682) – SONOMA COUNTY

On October 20, 2022, staff from the State Water Resources Control Board (State Water Board), Division of Water Rights (Division), conducted an inspection of Water Rights A014045 & A25682 located at Sonoma County Assessor's Parcel Number 116- 310- 053-000. The purpose of the inspection was to observe the diversion and use of water occurring on the site and to evaluate compliance with the curtailment order issued for the Russian River Watershed.

Enclosed is the Curtailment Inspection Report (Report) for Water Rights A014045 & A25682 that includes Division staff observations, findings, and the corrective action necessary for compliance with the emergency regulations. Division staff concluded that SCWC diverted water during the curtailment period for domestic use for human health and safety (HHS) purposes. The Curtailment Certification forms submitted for Water Rights A014045 & A25682 via the online portal acknowledges and certifies that the water is being diverted under provision 878.1 for health and safety purposes; however, there is no record of a Health and Safety Certification form on file with the Division.

Regulations require diverters who divert under provisions of California Code of Regulations Title 23 Section 878.1 for HHS needs must submit to the Deputy Director certification of compliance with the requirements. South Cloverdale Water Company must complete and submit the Human Health and Safety form for through the Water Right Form and Survey Submittal Portal at the following link:
