Attached is my hearing request form pertaining to Water Right A005303. I request that this hearing and penalty be waived, or that I be allowed to conduct the hearing by mail, or by phone, based on the following circumstances.

- I have filed the 2016 Annual Report for this water right. I confirmed that it was complete by phone with Mattew Quint at the Water Board on 11/5/18 (Matthew.Quint@waterboards.ca.gov;)
- The subject property is owned in common by multiple parties. I am the acting agent on an unpaid basis, and do my best to keep up with the filing requirements.
- The water usage has been relatively low for several years, limited to a small pasture area and landscape areas.
- I am not a water expert so the filing process was a learning experience. I completed the 2017 Annual Report within the required time frame and was under the impression I was not required to go back in time to file the 2016 report.
- I have been away of vacation for several weeks an received this notice only on my return

I appreciate the efforts the Water Board is making to monitor these water rights more closely, particularly in light of the on going water crisis in California. Now that I am accustomed to the reporting requirements I will complete our Annual Filing in a timely manner. I appreciate your consideration of this request to waive the hearing and the penalty.
