Biography of Rachel B. Hooper

Rachel B. Hooper joined Shute, Mihaly & Weinberger in 1984 and has served as the firm's Managing Partner since 1998. Before joining the firm, Ms. Hooper worked for two years as Law Clerk to the Honorable Laughlin E. Waters, United State District Judge, Central District of California. More recently, litigation filed by Ms. Hooper succeeded in halting construction of the Regents Road Bridge over Rose Canyon in San Diego.

In 2010, Ms. Hooper received the California Lawyer's Attorney of the Year (CLAY) Award for her success in challenging the Nestle company's proposal to construct a large water bottling facility on the McCloud River. She also received the Sierra Club Mother Lode Chapter's 2010 Outstanding Legal Representation Award, recognizing her achievement in negotiating a landmark settlement with the California Attorney General and the City of Stockton that calls for specific policies and programs to address the threat of global warming.

Among other current cases, Ms. Hooper represents environmental groups challenging the approval of a large ski resort on Dyer Mountain in Lassen County; challenging a large new development in Riverside County known as the "Villages of Lakeview," and opposing a controversial plan by Caltrans to widen the I-5 freeway along the San Diego

coast. She also represents environmental groups in proceedings before the San Diego Association of Governments with respect to its proposed 2050 Regional Transportation Plan, and in proceedings before San Diego County with respect to its General Plan Update.

Ms. Hooper has spoken widely on land use planning, CEQA, and initiatives and referenda. For many years, she has served on the editorial board of Matthew Bender's California Environmental Law Reporter.
