Subject: Deadline for Petitions for Reconsideration

Ladies and Gentlemen:

We have received several inquiries related to filing deadlines for petitions for reconsideration in the Fahey ACL/CDO matter. Section 1122 of the Water Code provides that:

The board may order a reconsideration of all or part of a decision or order on the board's own motion or on the filing of a petition of any interested person or entity. The petition shall be filed not later than 30 days from the date the board adopts a decision or order. The authority of the board to order a reconsideration on its own motion shall expire 30 days after it has adopted a decision or order. The board shall order or deny reconsideration on a petition therefor not later than 90 days from the date the board adopts the decision or order.

The Board adopted the <u>draft order</u> with the changes described in the attached errata sheet at its September 17, 2019 meeting. A final version of the order, incorporating the Board's changes and making any other necessary conforming (non-substantive) changes will be provided to the parties as soon as it is available.

Petitions for reconsideration must be filed not later than 30 days from September 17, the date the Board adopted the order. The petition process is further described in the attached email sent to the service list on October 1. Water Code section 1122 does not identify a process for extending the deadline.
