ENTRY AGREEMENT FOR POND & DAM ASSESSMENT ACTIVITIES

This ENTRY AGREEMENT for Pond & Dam Assessment Activities between Hidden Lakes Estates Homeowner Association (HLEHA) and Mr./Mrs. Allegra (hereafter referred to as "Owner"), effective 3/26/2007 through 5/25/2007, pertains to Owner's real property 8316 E. Hidden Lakes Drive, Granite Bay, CA (hereafter referred to as Owner's Property).

1. It is understood between Owner and HLEHA that:
 - A. HLEHA has contracted to have the two ponds and their dams in the common area to be assessed.
 - B. HLEHA desires to extend its dam assessment activities onto Owner's Property and;
 - C. Owner desires to have HLEHA enter Owner's property to conduct its dam assessment in accordance with plans prepared by HLEHA's contractor.

Therefore, Owner and HLEHA agree as follows:

2. Owner grants a temporary license to HLEHA, including its contractors, subcontractors and agents, to enter Owner's Property to perform assessment activities, which will be largely a visual inspection of the property and inspection/gauging of the onsite piezometers.
3. HLEHA will notify Owner three days prior to entry onto Owner's Property to determine a mutually agreeable time to conduct its assessment activities on Owner's Property. Notification shall be given to Owner at 916-797-1122.
4. HLEHA's assessment activities will be conducted under the oversight of HLEHA Common Area Planning Committee and will be supervised by Paragon Geotechnical, the contractor.
5. Assessment activities may occur between the hours of 8:00 AM and 5:00 PM, Monday through Friday, or such other days and times as agreed by HLEHA and Owner.
6. HLEHA shall remove from Owner's Property any equipment, and materials as soon as its assessment activities are complete. Although, no intrusive activities are planned by the contractor on the property, HLEHA shall restore Owner's Property as near as possible to its condition prior to the start of activities, if impacted.
7. HLEHA, its contractors, subcontractors and agents will comply with all local, state and federal laws, statutes, ordinances, rules and regulations while performing environmental activities on Owner's
