As described in California Code of Regulations, title 23, section 768, no later than thirty (30) days after adoption by the State Water Board of the order, any person interested in any application, permit or license affected by the order may petition the State Water Board for reconsideration of the matter upon any of the following causes:

- (a) Irregularity in the proceedings, or any ruling, or abuse of discretion, by which the person was prevented from having a fair hearing;
- (b) The decision or order is not supported by substantial evidence;
- (c) There is relevant evidence which, in the exercise of reasonable diligence, could not have been produced;
- (d) Error in law.
