NOTICE OF CANCELLATION OF PUBLIC HEARINGS

The State Water Resources Control Board
previously issued a notice to hold separate
public hearings to determine whether to adopt
Cease and Desist Orders (CDO)
against

Nelly Mussi and Rudy M. Mussi Investment LP,
for diversion from Whiskey Slough in San Joaquin County,
and

Juan Navarro,
for diversion from Middle River in San Joaquin County.

These two Public Hearings were
originally scheduled for June 7, 2010, rescheduled for
July 7-9, 2010, and then postponed indefinitely.

SUBJECT OF THE CANCELLED HEARINGS

The State Water Resources Control Board (State Water Board or Board) scheduled the hearings to receive evidence relevant to determining whether to adopt, with or without revision, draft cease and desist orders (CDO) against: (1) Nelly Mussi and Rudy M. Mussi Investment LP; and (2) Juan Navarro.

On December 24, 2010, the Division of Water Rights' (Division) Prosecution Team advised the State Water Board that the draft CDOs issued to Nelly and Rudy M. Mussi Investment (dated December 28, 2009), and issued to Juan Navarro (dated January 13, 2010) are withdrawn and that the Division's Prosecution Team does not intend to continue prosecution of these actions. Accordingly, no hearing is required to be held on the adoption of the proposed CDOs and the previously postponed hearings are cancelled.
