## NOTICE OF CANCELLATION OF PUBLIC HEARING

**The State Water Resources Control Board (State Water Board) has canceled the

(Application 28480) of the City of Rio Vista - Sacramento River in Solano County**

### SUBJECT OF THE CANCELLED HEARING

The City of Rio Vista (City) owns water right Permit 19873 (Application 28480), authorizing the diversion of water from the Sacramento River at a maximum rate of 9.6 cubic feet per second from January 1 to December 31 of each year (not to exceed 3,790 acre-feet of water per year) for municipal and industrial use. The permit requires that construction work be completed by December 1, 1989, and application of the water to the authorized use be completed by December 1, 2005. On August 25, 2006, the State Water Board, Division of Water Rights (Division) mailed a Notice of Proposed Revocation to the City, alleging that the City has failed to meet the project development deadlines required by Permit 19873. On September 7, 2006, the City filed a request for hearing on the proposed revocation.

The purpose of this hearing was for the State Water Board to receive evidence relevant to determining whether Permit 19873 should be revoked for failure to construct the project and to apply water to beneficial use as described in the permit. After further consideration, the City determined not to pursue the matter and, on December 21, 2006, the City withdrew its request for hearing. In the absence of a request for hearing or a disputed issue of material fact, no hearing is required to be held on the Division's proposed revocation of Permit 19873 and the previously scheduled hearing is cancelled.
